The UOVC Compensation Program offers a safety net for individuals affected by crime by providing financial assistance to help cover the costs incurred as a result of the crime. This support can include, but is not limited to, medical bills, counseling services, burial and funeral expenses, and lost wages. The program recognizes the impact crime has not only on the direct victims but also on their families, extending eligibility for assistance to family members who may also be facing financial hardships due to the crime. By easing the financial burden, the Compensation Program helps victims and their loved ones focus on recovery and healing during an incredibly difficult time.

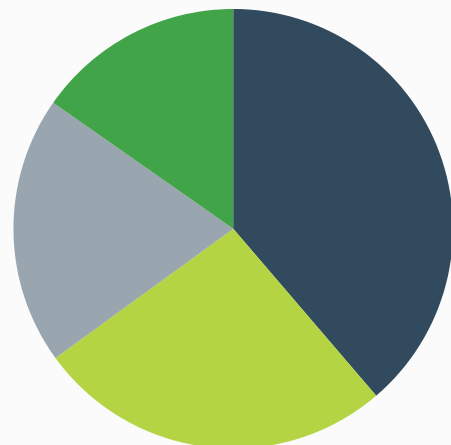

Sexual Assault Forensic Exams

UOVC covers services under the Code R Program that include the medical sexual assault forensic examination with photo documentation, the facility fee, medications for the prevention of pregnancy, and testing and treatment for sexually transmitted diseases.

The sexual assault forensic examination must be reported to law enforcement or DCFS by the healthcare provider performing the examination; however, a sexual assault victim is not required to participate in the criminal justice system or cooperate with law enforcement or prosecution to qualify under the Code R Program.

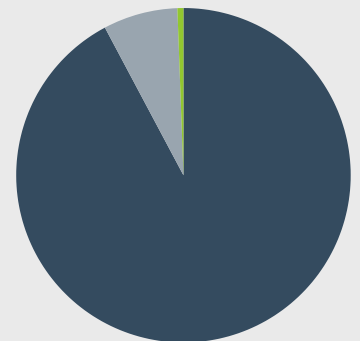
Advocacy Center

The UOVC Victim Advocacy Center provides essential support to individuals impacted by crime. Advocates guide victims through the reparations process, ensuring they can access financial assistance for expenses like medical bills and therapy. The center also offers crisis intervention, emergency financial aid for basic needs, and referrals to additional community resources. With a focus on addressing immediate needs and supporting recovery, the center helps victims navigate the challenges they face and move toward stability.

UOVC's Advocacy Center provides emergency funds to victims awaiting a determination on their compensation claim.

UOVC State Grants

Awarded by the Utah Legislature in the 2023 session, UOVC is responsible to provide funding for 1) Sexual Assault Services and 2) Other Victim Services, including but not limited to criminal justice victim advocacy programs, legal services for crime victims, and services that specialize in assisting underserved populations.

★ Victim Services

The purpose for this funding is to ensure that core services for all crime victims are available throughout the state, more specifically in the areas of criminal justice victim advocacy programs, legal services for crime victims, and programs that assist underserved victims of crime.

This funding allows a criminal justice, systems-based advocate to be funded in most counties in the State of Utah.

★ Sexual Assault Services

The purpose of this funding is to stabilize and enhance sexual assault services across the state of Utah.

Along with funding rape crisis centers across the state, this funding also provides support to two state-recognized coalitions which provide training and technical support.

UOVC Federal Grants

UOVC is the agency authorized to administer three federal grant programs for the State of Utah. These funds come from the Department of Justice's Office of Victims of Crime and Office of Violence Against Women and are awarded to agencies across the state to provide services to victims of crime.

★ **VOCA - Victims of Crime Act**

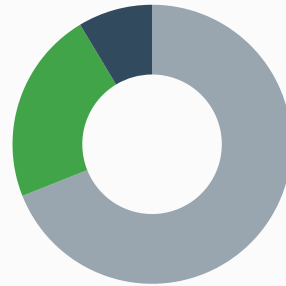
VOCA funding provides federal grants to support services for victims of crime. It helps fund programs like counseling, emergency shelters, legal aid, and other assistance to aid recovery and ensure victim rights.

★ **VAWA - Violence Against Women Act**

This grant program provides funding for projects that assist in efforts to reduce violence against women and men, specifically domestic violence, sexual assault, stalking, dating violence, and female genital mutilation. STOP VAWA Grants promote a coordinated, multidisciplinary approach to improving the criminal justice systems' response to violence against women. This approach envisions a partnership among law enforcement, prosecution, the courts, victims advocates, and service providers to ensure victim safety and offender accountability.

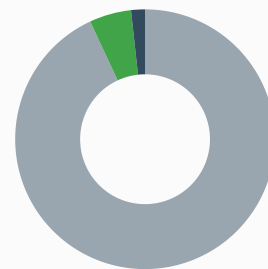
★ **SASP - Sexual Assault Services Program**

The purpose of SASP funding is to support the creation, sustainability, and growth of rape crisis centers and other nongovernmental or tribal programs dedicated to assisting individuals impacted by sexual assault, regardless of their age. These funds are specifically intended to provide direct intervention and related support services to ensure survivors receive the care and assistance they need.

A Brief Introduction to Victim Services Funding

VOCA

Eligibility: Public or non-profit organization which provides direct services to crime victims

VOCA funds programs like:

- Law enforcement victim service programs
- Domestic violence programs
- Sexual assault programs
- Children's Justice Centers
- Legal services and advocates
- Sexual assault forensic examiners
- Underserved and culturally specific victim services

VOCA supports nearly all crime types

STOP VAWA

Eligibility: Public or non-profit organization which provides direct services to crime victims

STOP VAWA funds programs like:

- Law enforcement officers, prosecutors and advocates
- Domestic violence programs
- Sexual assault programs
- Sexual assault forensic examiners
- Legal services
- Underserved and culturally specific victim services
- Specialized training programs



STOP VAWA supports victims of domestic violence, dating violence, sexual assault, stalking, and female genital mutilation.

SASP

Eligibility: Non-profit, non-governmental organization that provide direct services sexual assault victims of any age

SASP funds programs like:

- Rape crisis centers
- underserved and culturally specific sexual assault programs

The purpose of SASP is to provide intervention, advocacy, accompaniment, and related assistance for victims of sexual assault of all ages, their families, and those affected by the assault.



State

Eligibility: Public or non-profit organization providing direct services to crime victims

State funds programs like:

- Criminal justice victim services
- SANE programs
- Rape crisis centers
- Underserved and culturally specific sexual assault programs
- Sexual assault specific state coalitions
- Legal services and advocates
- Underserved and culturally specific victim services

State funding can support nearly all crime types

Training and Outreach Program

The Training and Outreach program focuses on providing training and technical assistance to victim service providers across the state of Utah. They facilitated four one-day trainings and three two-week academies. They also gave several presentations on various topics all throughout the state. Lastly, this team is actively participating in various committees and subcommittees that will affect victims of crime and improve systems.

TRAINING

SWAVO: Statewide Advocates for Victims Organization

Quarterly SWAVO training events were hosted in different regions of the state and via Zoom to ensure accessibility. These trainings are for victim service providers.

Total SWAVO Registered Participants: 550

Utah Victim Assistance Academy

40 hour comprehensive training that is in compliance with Utah Code 76-38-405. This is a two week training hosted three times for victim advocates in Utah.

Total Victim Advocates Trained: 73

Training Provided

The training team gave presentations to victim service providers and the community on victim rights, best practices in serving underserved communities, trauma informed response, mass violence, role of an advocate, and safety planning.

OUTREACH

14 Organizations were contacted to introduce UOVC programs and to learn about their organization.

The outreach team has worked to build a rapport with the tribal community by attending the tribal leader meetings and attending a Pow Wow in Cedar City.

The Improving Victim Services Strategic Plan was finalized in September 2023 and the taskforce was changed to the Improving Victim Services Taskforce in November 2023.
