This bill eliminates the supervision licensure time requirement of two years and reduces the number of supervision hours from 100 (a state regulated, national standard) to 75, which will be the lowest in the nation. The bill applies to all Utah Licensed Clinical Mental Health Counselors, Licensed Marriage and Family Therapists, and Licensed Clinical Social Workers. Curtailing this supervision jeopardizes the opportunity to develop competently skilled, ethically proficient mental health therapists while it amplifies the risk to public safety. The other provisions of the bill relating to telemedicine is supported by CCJJ and USA AV <sup>+</sup> ; and we see it as an option for telemedicine for behavioral health issues for individuals in immediate need and rural areas with appropriate coordination with DOPL.)
