USAAV+ Council Mission and Duties

The mission of the Utah Substance Use and Mental Health Advisory (USAAV+) Council is to create and coordinate a comprehensive strategy to eliminate substance use and mental health disorders throughout Utah.

The Council's statutory duties (§63M-7-301 through 306) are to:

- Provide leadership and generate unity for Utah's ongoing efforts to reduce and eliminate the impact of substance use and mental health disorders in Utah through a comprehensive and evidence-based prevention, treatment, and justice strategy;
- Recommend and coordinate the creation, dissemination, and implementation of statewide policies to address substance use and mental health disorders;
- Facilitate planning for a balanced continuum of substance use and mental health disorder prevention, treatment, and justice services;
- Promote collaboration and mutually beneficial public and private partnerships;
- Analyze and provide an objective assessment of all proposed legislation concerning substance use, mental health, and related issues;
- Oversee the implementation and evaluation of Utah's Drug-related Offenses Reform Act (DORA);
- Monitor the use of beer tax funds annually distributed to municipalities and counties for purposes of alcohol- and substance abuse-related law enforcement, prevention, treatment, detection, prosecution, and control to ensure compliance with the statute (§32B-2-404 and 405);
- Oversee Utah's Underage Drinking Prevention Media Campaign, ParentsEmpowered.org (§32B-2-306);
- Oversee coordination for the funding, implementation, and evaluation of suicide prevention efforts described in Section 62A-15-1101; and
- Report recommendations annually to the Governor, Legislature, Judicial Council, and Commission on Criminal and Juvenile Justice.

USAAV+ Council 2021 Ruminations

With changes to the legislative process to mostly virtual attendance, we adjusted and worked to inform the Governor's Office and the Legislature of policy changes, reviewing over 250 bills, and taking a position on over 150 bills.

USAAV+ 2021 Legislative Priorities

The 2021 Utah Legislature passed the following USAAV+ priority bills and appropriations during one of the most unprecedented Legislative Sessions in our State's history:

1st Sub H.B. 130 – Mental Health Coverage Amendments by Rep. Christine Watkins. This bill further ensures behavioral health parity in health benefit plans. Of important note, the bill requires a health insurer that offers a health benefit plan that provides a mental health and substance use disorder benefit to submit a report to the insurance commissioner each year that includes specified information and an analysis indicating the insurer is in compliance with certain state and federal laws governing mental health and substance use disorder benefits and requires the insurance commissioner to enforce certain federal laws governing mental health and substance use disorder benefits and specifies minimum enforcement actions that must be taken by the commissioner.

3rd Sub S.B. 155 – 988 Mental Health Crisis

Assistance by Senator Dan Thatcher. This bill creates the Statewide Behavioral Health Crisis

Response Account with the membership and duties as defined. This addresses the federal requirement that all states implement a statewide crisis response line with the designation of 988 to address crisis mental health emergencies and designates state funding to establish services and a public campaign to that purpose.



Behavioral Health Appropriations

Because of economic forecast changes, the Legislature held special sessions over the summer address pandemic concerns. USAAV+ Council advocated for the maintenance of critical behavioral health funding. Areas of focus included the underage drinking prevention campaign, continued funding of the behavioral health professional loan repayment program, and expansion of higher education behavioral health professional programs.



Utah's Underage Drinking Prevention Campaign

Parents Empowered is a statewide media campaign with the goal to have every Utah child reach the age of 21 alcohol-free so they can enjoy the benefits of a healthy brain. As a result of the decreasing rates of underage drinking, since 2009, it is estimated that 32,560 fewer Utah youth have ever tried alcohol, 18,805 fewer youth are regular underage drinkers, and 12,382 fewer Utah youth have experienced binge drinking.

As schools and workplaces closed, many parents and children socially distanced together at home. Sales of alcohol spiked to record highs both in Utah and nationwide, and people's media habits changed, with screen time increasing 50%, from 4.59 hours to 6.79 hours daily—much of it spent on social media and streaming services, such as Disney+. Like many programs and organizations, Parents Empowered reacted quickly to the "new normal," and the

campaign's changes and adaptations worked.

To help achieve these reductions in underage drinking, significant changes were made to the Parents Empowered campaign due to COVID-19. As campaign budgets were reduced and almost a quarter of a million dollars (\$236,523)

returned to the State's general fund, Parents Empowered cut the length of its TV and video advertising by half—from 30-second to 15-second ads—to save on production and media costs. With half the ad time to educate and motivate parents about underage drinking prevention, messaging was simplified and focused on the basics: That parental disapproval is the #1 reason kids choose not to drink, and that parents need to set clear rules and expectations about not drinking underage. According to the most recent June 2021 survey of Utah parents, conducted by Cicero, the simplified messaging worked, with 68% percent of Utah parents rating themselves as the greatest influence in their children's decision to drink or not, representing a 19% increase from the previous survey and a record high.

Parents Empowered has become the most creatively awarded ad campaign in the state. During the recent 2020-21 Utah American Advertising Awards, the campaign won more total awards than any other advertiser in Utah, plus the coveted "Best of Show."

Parents Empowered also leads in its community partnership opportunities. Because Utah ranks seventh in the nation for residents who identify as a gender or sexual minority, the 2019 SHARP Survey opted—for the first time—to include questions regarding sexual identity. The student-reported data showed that one tenth of Utah County students identified as LGBTQ+. Yet when a local prevention


FY 2021 Beer Tax Funds

The USAAV+ Council monitors the use of beer tax monies distributed annually by the Utah State Tax Commission to Utah's municipalities and counties from the *Alcoholic Beverage and Substance Abuse Enforcement and Treatment Restricted Account* for alcohol- and drug-related activities (§32B-4-4, 1Utah Code).

The Legislature appropriated \$5,651,400.00 for the fiscal year 2021. The total amount of funding expended may be less than the amount distributed because some municipalities and counties did not utilize all their funding during the fiscal year, in which case they may carry it over into the new fiscal year. The figure to the above shows how beer tax funds

coordinator assessed current resources to help address problem behaviors associated with LGBTQ+ youth, the critical gaps in prevention services became apparent. For example, of all 12th grade students surveyed in Utah County who also identified as straight, six percent reported consuming alcohol in the last 30 days. Yet, with the same scenario for those identifying as LGBTQ+, the rate was 13 percent. Further, binge drinking rates among LGBTQ+ twelfth graders almost triples that of their hetero classmates, from 4% for straight peers to 11.4% for LGBTQ+ youth.
